- 4. Electronic bids must be submitted to the office Barahatal Rural Municipality, Office of the Rural Municipal Executive, Kunathari, Surkhet through PPMO's e-GP system **www.bolpatra.gov.np/egp** on or before 12:00 noon on 2079/09/18. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM 2079/09/18 at the office of Barahatal Rural Municipality, Office of the Rural Municipal Executive, Kunathari, Surkhet. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2,01,500/-, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- 7. All other terms and conditions will be as per Nepal Government's prevailing Procurement Act and Regulations. Barahatal Rural Municipality, Office of the Rural Municipal Executive, Surkhet reserves the right to accept or reject the Bids.
